

Permit Endorsement Application (Specialised Species)



I hereby request that a Rehabilitation Permit Endorsement be issued to me. I understand that the conditions of the Permit Endorsement will be as follows:-

1. I must have adequate housing facilities and equipment to care for the species that I will be rehabilitating in accordance with the **Code of Practice – Care of Sick, Injured or Orphaned Protected Animals in Queensland** (“Code of Practice”) under the Nature Conservation Act 1992 and the housing standards as outlined in the relevant training material provided by WILDCARE.
2. I must have completed a relevant training workshops specific to the species that I wish to rehabilitate within the past 12-18 months of my application.
3. I understand that species, such as koalas, echidnas and venomous snakes are ‘specialised’ species and require additional rehabilitation needs and may be subject to a more thorough assessment procedure.
4. I must abide by all Rules and Regulations as set out in the WILDCARE Volunteer Manual and Wildcare Safety Management Manual.
5. I must maintain and submit regular Rescue/Carer Records as set down by WILDCARE, and I confirm that I have no Rescue/Carer records currently outstanding.
6. I understand and acknowledge that the decision on this application by the WILDCARE Management Committee is based on my completed training, experience, knowledge, facilities and the demand for wildlife rehabilitators in the region I reside. (Note: WILDCARE will generally only issue new Permit Endorsements for members that reside in the South-east Queensland council areas of Gold Coast, Logan, Scenic Rim, Brisbane, Redlands and Moreton Bay).
7. Should I require a Permit Endorsement for more than 20 animals, I must make application to WILDCARE and explain the need to have my Permit increased.
8. I agree to the WILDCARE Management Committee discussing my rehabilitation activities and this application with WILDCARE Species Coordinators and other WILDCARE key volunteers, Department of Environment and Heritage Protection (EHP), RSPCA Queensland, Australia Zoo Wildlife Hospital and Currumbin Wildlife Hospital and/or other relevant wildlife organisations which I am or have been a member.
9. I state that I am over 18 years of age. Permit Endorsements cannot be issued to members under 18.
